Remarks by DSCI Secretary - Paul Monteiro

- "Making Maryland a state that serves" is a priority for the Administration.
- DSCI's mission is to grow service opportunities, to remove barriers for participation, and to encourage service as a career pathway.
- The Maryland Corps/ Service Year Option will complement the existing AmeriCorps program to increase service opportunities across the state.

<u>Discussion of Portfolio and Grant Cycle Overview by Lisa Bishop, DSCI Director of Maryland</u> Corps Program

- 2024 calendar:

Grantee Presentation: Equity Now

• Representatives from Equity Now and Legends Charter School spoke about the impact AmeriCorps members have had in leveraging efforts to advance students' performance. This year, they have 30 AmeriCorps members for 900 students. Additional support allows teachers to focus on the classroom.

<u>Updates from AmeriCorps: Ms. Hartung and Mr. Forrest</u>

- Ms. Hartung provided a regional overview of AmeriCorps.
- American Rescue Plan and Public Health Corps funds are being phased out.
- A notice of funding for the VISTA program is open with a March 28th deadline.
